
如何處理

意外發生後 各項事宜

在意外現場

- 應保持鎮定,避免與對方司機追咎責任問題。
- 若有人因意外受傷,應立即報警及召救護車。警方到場後,會記錄意外的 詳情。
- 若無人受傷,應先把肇事車輛移到路 旁或安全地方,以免阻礙交通,辦妥 後,才與對方司機交換資料。

從對方司機獲取重要資料

- 根據道路交通條例,若意外發生後, 須錄取對方司機姓名及地址、車牌號碼、車主姓名及其地址等資料。
- 駕駛執照號碼、保險公司名稱、保單或保險証明書編號。
- 繪畫意外現場的草圖,並記錄當天的 天氣及現場的路面情況(拍下照片亦 有幫助)。
- 意外發生後,須立刻通知投保的保險公司,並填妥由該公司提供的意外報告表格。
- 在意外發生後二十四小時內,應到就 近警署報警。

- 若無人受傷,亦應考慮在二十四小時 內向警署備案。
- 若需投訴任何一方違反交通條例,應 在意外發生後十天內向警署報案。

修理汽車

如購有綜合保險,並打算索取賠償時,在維修車輛前,必須向保險公司提交維修報價表,並得保險公司同意後,方可進行修理。

意外之後

當收到警方或任何人仕的通訊時,應 儘速交給保險公司。


偷竊

- 如車輛或車內財物或零件被竊,應向警方報案。
- 並向保險公司報告有關事項。

WHAT TO DO WHEN AN ACCIDENT OCCURS





AT THE SCENE OF AN ACCIDENT

- Keep calm and refrain from discussing who was to blame with the other driver.
- If someone has been injured, call an ambulance and the Police immediately. The Police will take down the details on the spot.
- If no one has been injured, remove the involved cars to a safe place or to a safe side of the road, so as not to disrupt traffic flow, before exchanging particulars.

OBTAIN IMPORTANT INFORMATION FROM THE OTHER DRIVERS

- Name, address, vehicle registration number, name and address of the vehicle owner, which are required under the Road Traffic Ordinance.
- Driving license number, name of insurance company, insurance policy or certificate number.
- If possible, make a rough sketch of the accident scene and a note of the weather and road conditions (A photograph would also be helpful).
- The insurance company must immediately be notified of the accident with a fully completed accident report form.
- Otherwise, please report the accident to the nearest Police station or any Police officer as soon as reasonably practicable, and in any case not later than 24 hours after the accident.
- In case not involving personal injury, report the accident to any Police station within 24 hours is still recommended.

 If it is necessary to lodge a COMPLAINT for a traffic offence against any party, report the matter to the Police as soon as possible and in any case WITHIN 10 DAYS.

REPAIRING YOUR CAR

 If you have a comprehensive policy and you intend to make a claim, a detailed estimate of the cost of repairs must be submitted to and approved by your insurance company prior to the commencement of repairs.

AFTER THE ACCIDENT

 All communications received from the Police or any other party should be forwarded to your insurance company without delay.

THEFT

- If your car or some accessories or property inside the car has been stolen, you should report the case to the Police immediately.
- Then report the matter to your insurance company.
